Colossians

Later in April we begin a new worship series looking at the book of Colossians. If you want to get ahead, here are notes about the book taken from the Bible Society website-

Colossians lays out a vision of Christian living focused around the person of Christ (as laid out in the beautiful Christ-hymn of Colossians 1.15–20). In Colossians the vision of Christ Paul outlines in the first chapter is used as the underpinning for how those in Christ should now live. If they have died and risen with the Christ who created the world and is the head of the Church, their identity has now changed and they are expected to behave accordingly. Ephesians and Colossians are often recognised to be companion books as their message is very similar- both Colossians and Ephesians are letters that offer a vision of how to live out the Christian faith. In both, the theology of the first half of the letter is applied in the second half to everyday living.

According to the website, Colossians should take 13 minutes to read!

Annual Church Meeting

How is the U.R.C. run?



Acknowledging Christ as the head of the Church, the URC makes its decisions corporately when its members meet formally in councils. There are three different levels of decision making in the URC. These consist of: -

- -the local Church Meeting,
- -the Synod, which brings together representatives of local churches in a geographical area,
- -and the General Assembly, representing the whole of the Church in England, Scotland, and Wales.

Leadership and pastoral care in a church are generally shared by ministers and elders who are elected by church members. The congregations hold **Church Meetings** which are usually open to all, but at which only church members may vote. Prayer and discussion take place before important decisions are made.

Our own Annual Church meeting will take place after the service on Sunday 16th April.

The church members are responsible for electing Elders, and this time these Elders are due for re-election: Jill, Val, Ann J and Carol. The offices of Church Secretary and of Treasurer are also up for re-election.

The Church accounts are available and you may have questions to ask about those.

At this meeting we will also be hearing news of the building project and maybe getting a look at what goes on at Pilots- you may be surprised! Lots to think and pray about, so please come along and have your say, ask any questions you may have, and take part in our decision making. We need your input.

She is pleased to be back home and beginning the slow journey of recovery – there is still a long way to go but your prayers and good wishes are a real tonic and it is a joy to be feeling back in the 'real world' – well almost ...

During this time of recovery Kathy has reflected upon some of the roles and responsibilities she holds within the church – one of those being Church Secretary.

This is a role Kathy has held for almost 28 years. During that time Kathy has faithfully represented Hornsea URC at Synod; been the Pastoral Elder to the East Yorkshire churches; a member of the Ministerial Accompanied Self Appraisal team and an active member of the District Council, before it was disbanded, in addition to the day to day responsibilities of record keeping, overview of safeguarding, and most aspects of church life and ecumenical involvement across the town.

The Church Secretary works alongside a Minister in supporting the work of the church, its mission and pastoral care. In the absence of a minister so much falls on the secretary, along with the Elders, to provide this mission and ministry to both the congregation and the community.


